The Chairperson started with an overview of the agenda for the AGM:

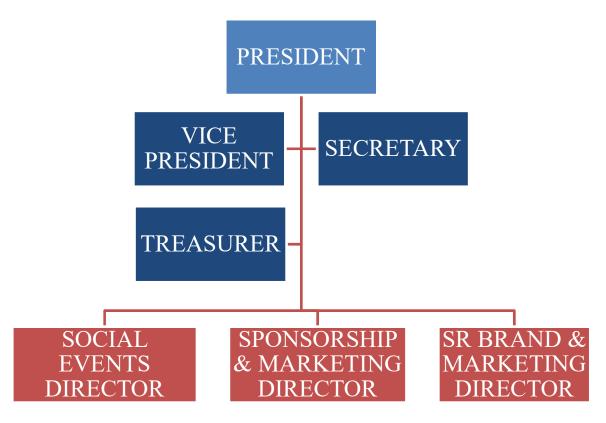
- To receive and consider the Financial Report of the Club in respect of the financial year ended 31st December 2022.
